Re: Temporary contract opportunity - provision of GP services for Registered Patients at Richmond Medical Centre (B86102) in Leeds

NHS England - North (Yorkshire and The Humber) are seeking expressions of interest from existing Yorkshire and Humber GP providers to secure registered GP services for the current registered list at Richmond Medical Centre in Leeds.

A brief overview of the services required is detailed below;

The practice is located at the following address; Richmond Medical Centre 15 Upper Accommodation Road Leeds LS9 8RZ

## GP/Primary Care Services

Providers will be aware that NHS England has commissioning and contracting responsibility for primary care contracts and provision of GP services for registered list patients. This temporary contract opportunity will be for a period of 12 months.

NHS England is looking to secure a provider to deliver services through a temporary APMS contract. The APMS contract will include the provision of;

- Essential services required for the management of Registered patients, who are or believe themselves to be ill;
- Additional Services;
- Directed Enhanced Services; and
- Locally commissioned schemes via the CCG.

There are approximately 2100 patients currently registered with the practice. The registered GP service currently operates between the hours of 8.00am – 6:30pm Monday to Friday.

NHS England is requiring provision of GP services to continue on this basis for the short term APMS contract.

## Contract terms

- The APMS contract will be for a duration of 12 months with the expectation of a full procurement process to be undertaken to secure services on a longer term basis.
- The APMS contract will be funded at £80 per patient for core services with the opportunity to deliver directed enhanced services and CCG incentive/quality schemes.
- During the interim contract period, NHS England will undertake appropriate patient and public engagement and consultation in accordance with procurement law with regard to the future tender for the registered GP service at Richmond Hill Medical Centre.
- The Contract must be mobilised for services to commence on or around the 5<sup>th</sup> October 2015.

NHS England would like to invite early expressions of interest from existing GP providers in Yorkshire & the Humber to deliver the service as defined above.

Providers who are interested must have the capacity and infrastructure to mobilise the service for on or around the 5<sup>th</sup> October 2015. Providers that express initial interest will be provided with further details on service requirements and the process that will be undertaken to evaluate bids and select a provider.
