Please see below further detail on exactly what we are looking to have sent out to your GP members.

The primary care GP's at each site work in collaboration with dedicated substance misuse teams and can draw support from pharmacy and the advanced nursing teams.

We are currently looking for GP's interested in either taking on regular commitments of 1 day to 2 days per week, or as back up GP's interested in working on a more ad hoc basis.

All 3 prison sites currently in need are easily accessible by main motorways and A roads and have parking available at the entrance to the prison.

If you are looking for a new role to give you some diversity in your GP career alongside your general practice then you can expect challenging and varied shifts working within prisons.
